QUILT SHOW ENTRIES, Members...Last call for Quilt Show Entries!!! Please remember bring your completed Quilt Show Entry forms to our January 31<sup>st</sup> meeting. If you have not done so, please pick up or fill them out at this meeting. Drop off your completed forms (with photos, accurate measurements and fabric swatches) at our Entry table at this VQG General Meeting. This year's 2024 Quilt Show and theme is "Colors of the Valley". The show will be held on March 9th & 10th, 2024 at the main exhibit hall, Y-S Fairgrounds. We will have Rule of Entry and Quilt show Entry forms for both Regular (Non-Judged) and Judged Entries (Judged forms are printed in Red type) forms and instructions are available at our table. So please stop by and pick up entry forms. Mailed entries can be sent to Pat May, PO Box 1166, Yuba City, CA 95992 and must be received by 1/31/24. We will no longer have our form available on our website. This did not work well for the 2022 Show and created too much additional paperwork.

### IMPORTANT Reminders and Additional F.Y.I:

- · All entries must have a completed Regular Entry form.
- ALL ENTRIES MUST HAVE A 3" SLEEVE SEW OR PINNED AT THE TOP OF THE QUILT BACK. No exceptions will be made!! Our new frame system requires sleeves on all article to be hung.
- · If your entry is to be Judged, it must have both a Regular Entry Form and a Judged Entry form, plus the \$5.00 entry fee.
- · Accurate Measurements please. Fabric Swatches & a good quality 4"X6" Photos need to be stapled of the top copy of the upper right corner of your Regular Entry form.
- · You must be a VQG Member to enter. (Please encourage anyone who wishes to enter to join the Guild).

### **IMPORTANT DATES TO REMEMBER:**

- · Last date to accept entries will be the January 31, 2024, at the VQG General Meeting.
- Entry numbers will be handed out on a 4" x 6" card at the VQG February General Meeting held on 2/28/24, your cloth labels will be attached to your card/receipt. A entry # is assigned to your quilt/article, please put this number on your quilt/article label. You will need to save this card, as it is your receipt to pick up your quilt/article after the show.
- · Delivery of **Judged Quilt Entries ONLY** Quilts are to be delivered March 5<sup>th</sup> between the hours of 8:30 a.m to 9:00 a.m. Fremont Rideout Conference Center, 989 Plumas St., YC this information will also be printed on your card/receipt.
- · Delivery of your Regular quilt/article These must be delivered to the Y.S. Fairgrounds on Friday, March 8, 2024, starting at 8:00 a.m. and are to arrive no later than 9:30 a.m.
- · Pickup Quilt/article must be picked up on Sunday, March 10, 2024 from 5-5:30 p.m. Bring your card/receipt to claim your item(s). We are looking forward to another wonderful show this next year!!! Give us a call if you have any questions!

**I. Call to Order:** A meeting of the Valley Quilt Guild Board was scheduled for November 13, 2023, at the Crossroads Community Church. The meeting was called to order at 4:05 pm.

**IV. Treasurer:** Accounting data entry and revised budget changes (see October 9, 2023 minutes) pending due to purchase of new laptop computer for the guild.

**Chamber of Commerce -** The ribbon cutting event will be held at the Quilt Show in March and the guild can advertise the event through the Chamber of Commerce.

**New Computer –** A new laptop computer was purchased for the guild; cost \$540.00. Quicken was successfully installed on the new laptop. The guild needs a laptop carrying case/bag, and password log book.

#### **Committee Reports:**

**Vice Presidents:** January – Melissa Milligan will be speaking. The Adventist-Rideout training room has been booked for the February, April and May workshops, as well as for quilt judging the Thursday before the quilt show in March 2024.

**Other:** Sharon Easter advised that the Yuba Sutter Fair likes our windsocks and suggested that we make some for the fair. After a discussion, Colleen and Eileen (and possibly Sandra Torres) will make a sock for the entrance of the fair and Cooky will donate the fabric.

**I. Call to Order:** A meeting of the Valley Quilt Guild Board was scheduled for January 8, 2024, at the Crossroads Community Church. The meeting was called to order at 4:05pm.

III. Secretary: A motion to approve the minutes of the November 2023 meeting as written was made by Eileen Milligan and seconded by Deanna Williams. <u>A unanimous vote to approve the minutes as written followed.</u>

Correspondence: A thank you note was sent to Vivian at Sew-n-Piece for her generous donation to the community service committee.

**IV. Treasurer:** The treasurer was not present. It was reported the checking account has a balance of \$4,294.52, fair equity account balance is \$2,129.49, and the savings account balance is \$10,747.77. Sandy Parker requested the quilt show budget be noted in future treasurer reports.

#### **Old Business:**

Christmas party – Colleen reported the income from the party was \$1,306 net, after all expenses. The dinner expense was \$1,025, dishwasher \$50, room rental \$13 a person and \$50 for candy, etc. Raffle tickets generated \$1,065.

**Auction** – Colleen stated the auction had a net profit of \$2,316.61.

#### **New Business:**

**Appointment of Bylaws Committee.** The Parliamentarian, Cooky Amarel, selected the following people to serve on the Bylaws Committee: Deanna Williams, Janell Willis, Colleen Pelfrey and Eileen Milligan. The committee will review the Bylaws, policies, and job duties as required every other year. They will report any recommendations to the Board in March, and if any changes are requested those will be presented to the Guild members for a vote at the general meeting in May 2024.

### **Committee Reports:**

**Vice Presidents:** February's general meeting will have demos in lieu of a speaker. The Rideout conference room is reserved-Saturday, February 3 for a free sew day. The room is also reserved for Thursday, March 7, for quilt show judging, and April 27 for an event to be determined.

**Community Service:** Diane noted that Vivian of Sew-n-Piece made a generous donation of over 115 yards of fabrics and other items to the guild. The new CASA (Court Appointed Special Advocates) in Yuba County has requested quilts for the children in their program. A motion to donate quilts to the new CASA program was made by Colleen Pelfrey and seconded by Cooky Amarel. <u>A unanimous vote to approve the motion followed.</u>

**Membership:** Nikki reported no changes to the membership numbers.

Quilt Show: Janell said the Chamber of Commerce Ribbon Cutting ceremony will be held on March 8, 5:30 p.m., at the fairgrounds. A subcommittee will designate the recipients of the quilts for the Avenue of Valor. The quilt show meeting zoom invites will be going out soon. It was noted that we will need a security person at the show. Diane Leighton suggested someone who might be willing to be the security person for security at the show. Colleen volunteered to take care of the keys if needed.

**Opportunity Quilt:** Deanna reported the opportunity quilt has made \$682 so far.

**Newsletter:** Leann advised that the deadline for newsletter items is the Saturday after the board meetings.

**Other:** Colleen is working on updates to the quilt website, to give to Terry Nugent.

**Adjournment:** The meeting was adjourned at 5:10 pm.
